CONTRABAND CONTROL

● FULL-LENGTH COURSE

Alcohol Abuse Emergencies in Jails/Prisons

2 HOURS

A large percentage of the US populations uses alcohol, and statistics state 85% of all inmates are involved with substances. All correctional officers should be aware of the signs of alcohol withdrawal and know how to deal with this problem. Likewise, inmates in prison may not be in withdrawal, but they can suffer serious alcohol problems from illegal substances "brewed" inside the facility. This course will give you training on recognizing the symptoms and how to take the necessary steps to assist inmates through this critical time.

Contraband Control

1 HOUR

Contraband is, in its basic form, anything that is not allowed to be in the possession of an inmate. Contraband takes on many forms and can also be something allowed in society but becomes illegal once it enters the correctional premises. Contraband can be drugs, cigarettes, or homemade weapons, which can pose a safety threat to the other inmates and the officers. This course will help you understand what is considered contraband, where to search and look for contraband, what to do with items seized, and the methods to help watch inmates who are trying to move contraband throughout the facility.

Persons with mental illnesses, drug or alcohol addictions, or disorders such as autism can present police officers with difficult challenges. In some cases, a person may brandish a weapon or otherwise appear to pose a threat to the public, to the police, or to himself or herself. The threat may or may not be real one, and often it is difficult to assess the level of danger. These situations become more complicated when, because of their conditions, persons cannot communicate effectively with police officers. Bloodborne Pathogens

This course assists officers in identifying bodily fluids and viruses that pose risk, the portals of entry, and what does and does not constitute an exposure. In addition, he/she will become acquainted with exposure prevention methods and precautions to prevent transmission as well as post-exposure steps and considerations.

Drug Withdrawal in Jail

Withdrawal is one of the most difficult medical issues that plagues correctional facilities across the nation. According to the Center for Behavior Health Statistics and Quality, in 2014 there were an estimated 27 million Americans age 12 and older who admitted to drug use. With a nation that is also incarceration happy, this makes for a troublesome combination in our jails and prisons. The challenges presented to correctional officers and probation officers are vast. This course aims at addressing those obstacles and bringing them to light.

Corrections Liability

1 HOUR

Corrections, like many of the facets of law enforcement, have had to change with the times. As members of the law enforcement community, it is important that you understand how to recognize situations and handle incidents and limit the liability for you or your department. We will also focus on how all inmates are to be protected and secured.

It's a dreadful thought your facility has lost control over the inmates and they are now in a position of power and manipulation. While no one wants to find themselves in this situation, your best chances for survival are to be prepared in the event it does happen. This course will look at some common causes of these disturbances, how to prevent them, and how to deal with them if they do arise.

Basic Jail Security Principles

1 HOUR

This course will shed light on the necessities for a safe and productive shift. It goes without saying that we all want to go home at the end of the day and the lessons contained in this course can help you walk out the door in one piece physically and mentally.

Booking and Admissions

1 HOUR

Corrections Officers have many responsibilities, but the most important is keeping the facility safe. The booking and admissions phase is arguably the most vital challenge for officers. Classification of Inmates

This course will help you understand the importance and what action you as a correctional officer can take to safeguard your fellow officers and the inmates.

Inmate Correspondence

1 HOUR

While inmates/detainees receive a variety of items in the mail, all of their mail will be reviewed to ensure safety and security within the facility. This course focuses on how to keep your eyes out for malicious and potentially harmful correspondence.

Inmate Employment

1 HOUR

Providing inmates with meaningful work helps prevent idleness and reduces boredom in the interest of maintaining an orderly, productive jail environment. Work programs also teach valuable job skills that can help inmates succeed after they are released. Establishing a fair, safe, and rewarding inmate employment program can provide positive reinforcement and opportunities for inmates to earn money and perks while helping to offset the costs of operating your facility. In this one-hour course, Corrections Officers will gain deeper insight of inmate employment programs, and their legal implications.

Inmate Record Keeping

1 HOUR

The one-hour Inmate Record Keeping course is vital to Officers in a correctional facility. Keeping accurate logs and records of inmates will ensure an efficient and safe environment for inmates, officers, and the public.

Jail Release Procedures

1 HOUR

Releasing inmates from your facility, whether it is for bail, time served or to another agency, is an event that deserves scrupulous attention to detail. No words have ever caused more panic and alarm than "Erroneous Release" or "Release in Error." If you are an officer or supervisor working in this area of the facility, you know just how much work goes into releasing an inmate and how much could potentially go wrong. This course will highlight the different types of release as well as the necessary procedures that go along with them. It will also include recognizing how errors happen as well as how to properly release inmates without error.

Managing Employee Records in Correctional Facilities

1 HOUR

This one-hour course will provide you with the instructions to make sure all employee information is kept safe and confidential.

Supervising Inmates

1 HOUR

Supervising inmates can be a very rewarding experience if you work hard to sharpen your skills. Chances are very good that if you apply the skills you will learn in this course, you will find yourself to be a much more efficient and effective supervisor. Moreover, you may find that by improving your supervisory skills you can earn greater respect from peers, supervisors, and a majority of the inmates at your facility.

Supervision of Inmates in Dining Areas

1 HOUR

While more of the world has fond memories of dining en masse in schools for lunch, a time shared with friends in a comfortable setting, the opposite is true for dining in correctional facilities. This brief window of time presents one of the highest risks for assaults and riots as well as other disturbances that make eating much less than enjoyable. This one hour course will address the dangers that can be expected and provides the learner with suggestions to limit these confrontations.
